This document sets out the fees that are charged to FireQual Approved Training Centres for the delivery of FireQual qualifications and does not set out the costs associated with delivery to those wishing to undertake one of the qualifications listed.

To discuss the costs associated with delivery to the candidate, please speak with one of the Approved Training Centres who will be happy to provide this information.

All fees that FireQual quotes are exclusive of VAT which we will apply at the time of invoicing unless an organisation has previously declared and provided evidence of an exemption.

Invoices should be paid within 30 days of the date of issue unless previously agreed by FireQual. The invoices will show the charges for the services that have been provided by FireQual and any additional charges that may relate to P&P and VAT at the applicable rate.

Invoices will be sent to the finance contact, as notified by the Centre, or the point of contact if no separate individual has been identified.

It is important to keep FireQual updated of any changes to the finance contact to avoid any delays and resulting disruption to the delivery of services.

Approval and Re-Approval

On completion of the approval process, the organisation will be required to make full payment of the Centre approval fee prior to the approval being finalised.

Centres re-approving for a further 12-month period will be required to make full payment of the re-approval fee prior to the re-approval being finalised.
